In pursuance of Food and Procurement Policy, 2009-10 communicated vide Letter No.21243 /FS & CW dated 05.10.2008, the following WSHGs/Pani Panchayat of Keonjhar / Anandapur Sub-Division are hereby allowed to procure paddy from the farmers at the rate of Minimum Support Price (MSP) declared by the Government for the Kharif Marketing Season, 2009-10 subject to the terms and conditions laid down hereunder:

### **TERMS & CONDITIONS**

1. The WSHGs/ Pani Panchayats are tagged to the OSCSC Ltd., Keonjhar & authorized to purchase up to 15 quintal paddy from a farmer during the entire KMS in cash. Quantities of more than 15 quintal may be purchased only against A/C payee cheque to be issued by the WSHG/ PPs or by the State Govt. Agency (OSCSC). The OSCSC shall lift the paddy from the WSHG/Pani Panchayats concerned at least once every fortnight or more frequently, if required, so that WSHGs/farmers do not face any inconvenience.
2. All payment by the State Govt. Agency (OSCSC) to the WSHGs shall be made only by A/C payee cheque only & WSHGs/Pani Panchayats will ensure that FAQ paddy is procured from the farmers at MSP. The Govt. have fixed the Minimum Support Price (MSP) of different varieties of Fair Average Quality (FAQ) standard of paddy for the KMS, 2009-10. The Minimum Support Price (MSP) as announced by the Government, at present, is given below:
  3. a) **Common Paddy – Rs.950/- (Rupees nine hundred and fifty) per quintal**
  - b) **Grade-A paddy- Rs.980/- (Rupees nine hundred and eighty) per quintal**

**Besides above, an Incentive Bonus of Rs.50/- (Rupees fifty) only per quintal will be paid over and above the MSP as per Letter**

**No.23815/FS &CW dated 5.11.09.**

4. The quality specification of paddy and rice as decided by the Govt. of India shall be applicable.No Agency including WSHGs/PPs are allowed to purchase FAQ paddy at prices below the Minimum Support Price (MSP) fixed by the Government for the KMS, 2009-10. Purchase of FAQ paddy at prices below the MSP would amount to violation of the Orissa Rice and Paddy Procurement (Levy) and Restriction on Sale and Movement Order, 1982 and will be punishable under E.C. Act, 1955.
5. The WSHG/PPs ( Pani Panchayat) will keep records of procurement in the prescribed format containing the details of farmers ID / card number or other proof of identification, name,address,date of purchase and will issue proper “ vendor receipt” to the farmers at the time of purchase of paddy.
6. In order to prevent mis-use of this facility, farmers residing within a radius of not more than 10 Kms from the WSHG/PPs concerned only would be allowed to sell paddy to the WSHG.
7. The WSHG/ PPs is tagged with nearest Departmental Purchase Centre (DPC) opened by the OSCSC Ltd., Keonjhar. The OSCSC Ltd.,Keonjhar will lift the paddy from the premises of the WSHG/PPs concerned at least once every fortnight or more frequently, if required, so that WSHG/PPs/ farmers do not face any inconvenience. The cost of paddy will be released by the OSCSC Ltd., Keonjhar by A/C payee cheque only.
8. Payment of at least one third of the total cost of paddy sold should be made on the spot and the remaining amount should be paid preferably within two days, but not later than seven days in any case.
9. As per Letter No. 20158 (60)/ FS & CW dated 17.09.2009 of the Govt. in Food, Supplies & Consumer Welfare Department, Orissa, the Commission to the Societies, Self Help Groups & Co-operative Societies undertaking procurement of paddy on behalf of the F.C.I./ State Agencies etc. will be allowed at a maximum of 2.5 % of MSP for the Kharif Marketing Season (KMS) , 2009-10
10. Equipment for weighment of paddy, gunny bags and moisture metres etc. will be provided to the WSHGs/PPs by RMCs and paddy procuring agencies.
