
Further you are requested to follow the following instructions.

- 1 School wise enrollment position & distribution list to be collected from concerned B.D.O.s. in writing before delivery.
- 2 Delivery of good quality of eggs should be made immediately at school point for **1st fortnight of March-2010** by 10th March 2010 positively. The Teachers receiving the stock should made complete check of eggs at the time of delivery by putting into in the water to ascertained the quality of eggs. Rotten/not good eggs shall be replaced by the supplier at his cost at once. If there is LATE DELIVERY the Headmaster/ Teacher shall NOT receive the stock and this will amount to violation of Agreement executed with us.
- 3 Eggs will be supplied @ 3 (three) eggs per student during this fortnight.


4. Delivery should be made only to the Headmaster/ Teacher authorized by the BDOs.
5. Maa Mangala Poultry Producers Co-Op. Society Ltd. At-Swarupvilla, PO- Budhikhamari, Dist. Mayurbhanj. MUST deliver eggs through DELIVERY CHALLANS in quadruplicate – 1<sup>st</sup> copy would be kept with the supplier, 2<sup>nd</sup> copy with the School and 3<sup>rd</sup> & 4<sup>th</sup> copy with signature of the teacher concerned should come to the Block office . BDO should keep one copy and send the other one to the DSWO with his countersignature after which payment will be made.
6. On receipt of Acknowledgement from the concerned HM/Teacher, the concerned BDO should tally the signature of the teacher placed on the body of the delivery challan with that signature maintained in the specimen signature guard file. The BDO should also verify the quantity of Eggs indented per school with the actual quantity delivered. If there is any discrepancy in quantity, or if any school is left out and if there is any delay of delivery, those MUST be specifically mentioned to the DSWO otherwise the BDO shall be held responsible for such discrepancy, delayed delivery , & defeating the programme of Government.
7. These above instructions are mandatory to be followed. If there is any laxity on the part of the supplier, those should be reported by the BDOs otherwise the BDOs shall be held responsible. If there is any laxity in the office of the BDO, then the BDO shall be held responsible.


