With reference to the letter cited above on the subject, I am to say that, your sample of Dal has been approved by the testing committee on 17.03.2010.

Therefore you are requested to distribute the "Dal" directly to the School points/ Anganwadi centres after obtaining the School wise distribution list/ Anganwadi wise distribution list from concerned B.D.O.s/ C.D.P.O.s.

Further you are requested to follow the following instructions at the time of distribution of Dal.

1. School wise & Anganwadi Centre wise enrollment position to be collected from concerned B.D.O.s. & C.D.P.O.s in writing before delivery.
2. Delivery of good quality of Dal should be made immediately at school point / Anganwadi Centre within 15 days positively. If any LATE DELIVERY is made/ any school/ AWC is left out, this will amount to violation of Agreement executed with us.
3. Delivery should be made only to the Headmaster/ Teacher/ Ang Contd.... Worker authorized by the BDOs/ C.D.P.O.s whose specimen signature is available with B.D.O./C.D.P.O.
4. Suppliers should follow up the instruction communicated to them vide Memo No.115/ Res./ Dt.21.1.2009 of the undersigned.
5. On receipt of Acknowledgement from the concerned HM/Teacher/AWW, the concerned BDOs/ CDPOs should tally the signature of the HM/teacher/AWW placed on the body of the delivery challan with that signature maintained in the specimen signature guard file. The BDOs/CDPOs should also verify the quantity of Dal indented per school/AWC with the actual quantity delivered. If there is any discrepancy in quantity, or if any school/AWC is left out and if there is any delay of
