



2. Any interested party can submit his/her quotation to the District Project Co-ordinator, Sarva Sikhya Abhiyan, Keonjhar only through post/courier/tender box (not to be received by hand) by 1p.m of Dt. 03/05/2010. The quotation received after the due time and date fixed will be rejected.
3. The quotation will be opened on Dt. 03/05/2010 at 4.30p.m at the Res. Office of Collector, Keonjhar; in which the quotationers or their authorized agents may attend.

4. Preference would be given to the firm having minimum 2-3 years experience for data entry of similar type of work in Central Govt./State Govt./Public Sector undertaking/any district/OPEPA CTS data entry work.
5. The rate quoted including the cost of providing required nos. of computer & other related accessories for LAN, Data Entry Operators (DEOs), approximately for running 10 computer (P4 systems or higher configuration) with 20 DEOs.
