The Block Development Officer, Hatadihi Block on behalf of Panchayat Samiti, Hatadihi Dist:-Keonjhar invites item rate bids for the following works as detail in table from eligible class of contractors as mentioned below registered with State Government and Contractors of equivalent grade/Class registered with Central Government /Railways/MES for execution of Civil works on production of definite proof from the appropriate authority. The sale and receipt of the bid documents shall start from 11.03.2010 (11 AM to 3 PM).. and close on 16.03.2010 at 3 PM. The Bid shall be received in Panchayat Samiti, Hatadihi.

Bid document consisting of Plans, Specification ,the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in all the officers issuing the tender documents during office hours everyday except on Sunday and public holidays till last date of sale and receipt of tender papers. Interested Bidders may obtain further information at the above address.

The bids must be accompanied by EMD/security of the amount specified for the work in the column 5 of the table. The bid security will have to be in any one of the forms as specified in the bidding documents. E.M.D is to be deposited duly pledged in favour of the Block Development Officer, Hatadihi in shape of NSC/POTD/Kisan Vikash patra.

Bid documents can be purchased from office of the panchayat Samiti, Hatadihi against a non refundable fee towards the cost of documents in shape of cash on production of original valid PAN card, Contractor license and VAT clearance certificate in form (VAT-612), Income Tax clearance Certificate.

The bidders are required to submit the attested copies of the valid registration certificate, PAN Card, ITCC, VAT clearance (VAT-612 form), labour license clearance, no relation certificate along with the tender while submitting the tender papers failing which his/her tender shall not be considered. The original documents are to be produced before the undersigned as and when required.

The bid documents must be delivered in the Tender Box having identification no. PS, Hatadihi-01/2009-10.

The bids will be opened on Dt. 16.03.2010 at 3.30 P.M. in the office of the undersigned in the presence of the bidders of their authorized representatives who is to attend. If the office happens to be closed on the date of receipt/opening of the bids as specified, the bids shall be received./opened on the next working day at the same time and venue.

Other details can be seen in the bidding documents.

10. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
11. The Contractors have to furnish an affidavit about the authentication of Tender documents.
12. The Engineering Contractors seeking exemption of EMD have to produce their original license at the time of opening of tenders for entering into EMD exemption clause since they can participate maximum in three works in a financial year with such exemption for which necessary undertaking is to be produced in the form of an affidavit in this norm.
13. Additional performance security will be deposited by the successful bidder when the bid amount is seriously unbalanced i.e. less than the estimated cost by more than 10%. In such an event the successful bidder will deposit the additional performance security to the extent of the differential cost of bid amount and 90% of the estimated cost in shape of post office saving bank account/national savings certificate/Post Office time deposit/ Kissan Vikash Patra/Deposit receipt of schedule bank duly pledged in favour of Block Development Officer, Hatadihi.
14. SC & ST Contractors should submit attested copy of the Caste Certificate and he/she should submit a claim application in this regard
15. Conditional tenderers are not acceptable.
16. Transfer or adjustment of EMD will not be entertained.
