

3. The tenders are required to deposit E.M.D of Rs. 5,000/- (Five thousand) only in shape of Bank Draft drawn in favour of Collector, Keonjhar at any Nationalized Bank at Keonjhar along with the tender documents.
4. The tender papers will be received in the office of the A.D.M,Keonjhar up to 9.00 P.M on 07.06.2010 and will be opened at 11.00 A.M on the same day by the Collector, Keonjhar or his authorized officer on his behalf in his office chamber in presence of tenders or their authorized representatives.
5. The tender received after the due date and time as will as without sample E.M.D and any other required documents shall not be taken into consideration.
6. The charge towards VAT, packing forwarding and freight etc. should be included in the price.
7. The rate quoted should be valid up to 31.07.2011
8. the sample of each item will be examined by the purchase committee for their consideration and approval.
9. The list of the sports item and quantity enclosed in this tender are tentative but the purchase order will be placed as per actual requirements subject to availability of funds.
